1. Mayor Update

Mayor Lorenzo Sandoval resigned as he will no longer be a resident of Red Cliff. Board of Trustees unanimously supported Duke Gerber as the next Mayor to fill the position until the next election in April, 2020. The next Mayor Pro tem will be nominated for approval of the Trustees on February 19, 2019.

2. Administrator Update

The Mountain Community Summit "YIMBY" was held on Jan. 17. Representatives for Eagle County, Developers and interested parties attended. Focus was bringing more workforce housing into the Valley, some of the incentives that can help developers, ways to acquire land for the specified use and what can be written into policies to achieve this.

CDOT met with Administrator and Planner to review the process for the bridge replacement at the Water Plant. It was evident that with the federal grant that much more money will be necessary for engineering and oversight of the project. Administrator to look for more planning grants for the bridge.

The office and maintenance are still short staffed. Opennings are posted and ads in the Vail Daily have been placed.

The County will be doing rockfall mitigation on High Street this summer. They will be contacted in the hopes that the bear head will remain and not be destroyed.
