1. Mallory Parks, Red Cliff Liquors requested to have a liquor tasting event on Fridays at the shop. The request will be referred to the Liquor Board and on a coming agenda.

#### **PUBLIC HEARING - SPECIAL REVIEW USE APPLICATION**

1. Special Review Use Approval is requested by an Adventure Rental Company. "Rocky Mountain Adventure Rentals" currently doing business from their Eagle-Vail location is requesting to expand with a location in Red Cliff. Their business includes off-road and on-road motorized and non motorized equipment.

Clay Bidwell and Stan Morris discussed their business model which included high-end equipment for small parties of up to a total of 12 persons. The location would be in the old Reno, with storage in the old Post Office; 127 and 147 Water Street. The Board was pleased to see many residents participate. Many voiced opinions concerning the number of snowmobiles currently on our roads and local snow play areas, drastically changing the character of our town, leaving little quiet time and road damages on town roads and up Shrine Pass. There were comments in support of RMAR bringing their business into town.

The RMAR team and Town Trustees will be looking for ways to mitigate some of the concerns through signage, fines, fees and other suggestions from Residents. A planning & zoning meeting will be called and posted as soon as the applicants have a complete plan. Residents and any others with interest will be invited to participate.

#### **UPDATES**

1. Mayor Update

Mayor Gerber mentioned that with the excess snow the fire hydrants really need some shoveling out. Trustee Blevins volunteered the Girl Scouts to help with the hydrants. Administrator noted there is a shovel with locations of the hydrants inside the outer doors of Town Hall (always open). A note regarding hydrants will be inserted in the town newsletter with the water bills.

#### 2. Administrator Update

Jerry Trujillo's Memorial was well attended and filled the auditorium. It was a nice service for his sons and others to pay their respects.

A discussion with the CML representative regarding the CDOT grant for the Water Plant bridge to ask for additional funds or a secondary grant. The CDOT engineers felt the request was too short on funds due to the requirements for a federal grant.

The Street Project RFQ will go into the paper soon to get solid amounts for any grant requests.

Unfortunately, Charlie Davis, our building inspector with RG and Assoc. has resigned to take a full time position with the Town of Eagle. His last day is March 22<sup>nd</sup>. SafeBuilt may also be moving out of the mountain area. We are in a poor position for hiring a building inspector as it is not a FT position. We will be looking for another company if RG & Assoc. does not find someone.

CML Conference will be held in Breckenridge in June. A hotel room has been secured as the group of rooms specifically for the conference are all reserved. CIRSA will have a training on the day prior to the Conference and will be free to attend with mileage reimbursed by CIRSA.

Vail Board of Realtors has an event on the 21<sup>st</sup> where I will be presenting Red Cliff information.

Downtown Colorado, Inc. has asked Scot Hunn to give a presentation regarding the results from the event we attended last year in Boulder. I will be helping present our take on the event during one day of this year's event.
