PUBLIC COMMENTS

Asking permission to park a trailer on Town property on November 22-25, 2019, to help with his move. Motion by Duke Gerber to approve this request, seconded by Valarie Blevins, unanimously approved.

PUBLIC HEARING – SPECIAL REVIEW USE APPLICATION FOR RMAR

- Presentation of business model and location. Clay Bidwell (Buena Vista), Brian Forkner (Gypsum) and Stan Morris, (286 Eagle Street, Red Cliff) presented details and answered questions from the public.
- Questions and Comments from the public. There was a general concensus that this location is a better
 option than the previous location. Many concerns were noted by the residents in attendance. The
 concerns included additional fees to compensate the Town, environmental impacts (such as noise, air
 quality, water impacts), limiting use of town roads, storage of machines, and impacts to the quality of
 life within the Town.
- Committee Questions. Questions were asked for clarification regarding the cancllation of the previous permit with the approval of this one, additional fees, and a limitation of use of Town roads.

DISCUSSION & ACTION ITEMS

1. Planning & Zoning referral for BOT review – Martinez Addition, 268 Water St.

Motion by Duke Gerber to approve the addition with condition that proof be shown that improvement will not encroach on town ROW, seconded by Valarie Blevins, unanimously approved.

2. Planning & Zoning referral for BOT review – RMAR recreational rentals, 166.5 Eagle St. Board discussed potential additional fees or taxes and directed staff to look into what other towns do in this situation. They also discussed potential restrictions of number of allowed SUPs like this in the Town. Motion by to accept P&Z recommendation of approving the Special Use Permit for RMAR with the conditions laid out by the P&Z commission (revoking previous SUP and Scot Hunn's conditions) by Valarie Blevins. Seconded by Duke Gerber, unanimously approved.

3. WTP Bridge Update

Footers were poured today. They have passed all inspections. Looking at completion of the project in December.
