1. Fee Schedule Update including additional fees for Motorized Rentals

Extensive discussion on current fees and taxes, as well as specific identification for local machines. Residents at the meeting expressed concern for potential registration fees placed on locals. They did express a common view that motorized rental companies should be responsible for a \$2 fee payable to the Community Fund as well as a 3% fee to the Town to assist with covering the costs of enforcement of regulations on motorized vehicles with in Town limits. The Board directed staff to look into drafting Resolutions for said fees to motorized rental companies and for a local registration option/stickers.
