#### **PLEDGE OF ALLEGIANCE**

#### **APPROVAL OF AGENDA**

Motion by Valarie Blevins to approve the agenda, adding a Discussion & Action Item #3 regarding a cigarette tax in Town, seconded by Duke Gerber, unanimously approved.

#### **APPROVAL OF MINUTES**

1. December 17, 2019

Motion by Valarie Blevins to approve the minutes, seconded by Tom Henderson, unanimously approved.

#### **PUBLIC COMMENTS**

Nathalie Roy, 410 Eagle Street, proposed an ice-skating rink in the old gymnasium with a wooden frame and a bladder, which could be built and maintained by community members. Discussion on this included ensuring that the building can handle the weight of the rink; this topic will be on the next agenda.

Nathalie Roy, 410 Eagle Street, proposed that we have a Christmas tree burning event. Discussion on this included the possibility of holding it at the old dump on Friday, 1/10/20, pending permit approval.

Community members inquired about the gate to the Cemetery Road being locked. The Board and Staff explained that this was due to snowmobilers causing damage to the Cemetery.

# **DISCUSSION & ACTION ITEMS**

1. Short Term Rentals – discussion of requirements, possibly including the number and area where they may be allowed in Town, Business fees and requirements, and other concerns.

Mayor, Duke Gerber, has spoken with Property Managers in the valley about their experiences with short-term. Staff explained that the current requirements include that any type of short-term rental must have a current business license, apply for a Special Use Permit, and pay the required lodging tax. This was a continued discussion by the Board and community members, in which there was considerable agreement that regulations on the amount of Short-Term Rental SUPs that should be allowed and the length of time and renewal specifics need outlined. However, these details need additional research and input from residents.

2. Town of Red Cliff - Election Update

Nomination Petitions for the Board of Trustees open seats and Mayor are available. They need to be completed and returned by January 27, 2020. For the ballot election, which will be held at Town Hall in April, we will need some election judges.

3. Cigarette Tax for the Town of Red Cliff

Eagle County passed a \$4/40% tax on cigarettes and other nicotine products on their last ballot. Our one retailer of these products will be responsible for collecting and forwarding this tax to the County. This will be onerous for this small business. In addition, any towns in the County who have their own cigarette/nicotine tax will get to continue to keep their tax and pay the difference to the County. For instance, the Town of Avon already has \$3 tax in place – they will increase the tax to \$4, keeping \$3 and sending \$1 to the County. This is inequitable to towns such as Red Cliff, as we will be sending all \$4 of this tax to the County and keeping none of it here in our community. The \$4/40% tax is going into effect no matter what, and if we want to keep the tax revenues in our Town, we need to pass an Ordinance to get this tax increase on the upcoming ballot.

The Board directed Manager, Barb Smith to move forward with this.
