DISCUSSION & ACTION ITEMS

1. Short Term Rentals

Discussion amongst residents and the Board brought about such concerns as: the potential of these types of businesses undercutting our local lodging business and not operating at the same standard of this business; personal resident's experiences of constant noise and a lack of respect for neighbors and the Town in general (such as late-night-parties, parking incorrectly, issues with dogs, etc); cost, both monetarily and of time required to certify safety, code compliance, and tax/license collection and management, being significant to the Town; and the potential revenue to the Town would likely not cover the costs of enforcing and managing these types of businesses.

Of the benefits of setting up regulations for short-term rentals and allowing them to operate in the Town of Red Cliff, the discussion continually laid out that the costs out-weighed them. The Board of Trustees directed staff to draw up an Ordinance to disallow short-term rentals in the Town of Red Cliff.

2. Town of Red Cliff - Election Update

Six Nomination Packets have been signed out, which are due on 1/27/2020. Starting then, anyone interested in being a write-in candidate has until 1/31/2020 to register to do so. There will also be the tax item on the ballot. We will need election judges for the election day.

3. Ice Rink
