## **APPROVAL OF AGENDA**

Motion by Valarie Blevins to approve the agenda with addition of the Proclamation after Ordinance 3 and an Executive Session after the updates, seconded by Amelia Neat, unanimously approved.

### **DISCUSSION & ACTION ITEMS**

1. Citizen Action Plan – Review of Outreach for the Streetscape Plan and next steps.

Barb Smith explained that we have had a few outreach events and opportunities thus far. We will continue to have more of these to ensure that residents are able to give their input and understand the project. This grant is for \$288,000 with a \$5,000 match.

2. Town of Red Cliff - Election Update

We have 1 candidate for Mayor, 3 candidates and 1 write-in candidate for Trustee. The order of the names on the ballot were drawn and are set. There will also be the Cigarette Tax on the ballot.

3. Ice Rink Discussion

We still need some community members to volunteer to move this project forward.

4. CBR Garage application delay request.

CBR is trying to get a SRU Permit for their garage located in town. They are struggling to get a surveyor up here as well as struggling to get their Eagle County Permit for Shrine Road. Due to these issues, they are asking for a continuation of their variance. After discussion by the Board, there was a motion by Duke Gerber to direct staff to give CBR notice that the Town will extend their garage variance request and to give them information about the changing rules regarding driving their machines into Town (to their garage), seconded by Valarie Blevins, unanimously approved.

- 3. Other Staff/Trustee Updates

Deputy Clerk, Melissa Matthews:

- On 1/22/20, I Attended the "Getting to Zero" event with the County's interest in reducing emissions from a systematic angle, maybe we can convince them to get more bus routes up here? And, maybe with the smaller busses just between Minturn and Red Cliff?
- On 1/23/20, I attended the Census meeting in Eagle. We will need to be sure our residents understand
  that the outcomes of the Census will significantly impact our Town for the next 10 years. We need to
  inform them that they will not receive their questionnaire in the mail, so they will need to answer the
  door when a Census worker comes to it or complete it online. The library may be able to set up a kiosk
  for people to use.
- I am working on a submission for the HGTV's Town Makeover show.
