# **APPROVAL OF MINUTES**

1. March 3, 2020

#### **PUBLIC COMMENTS**

Community Members were happy with the voter turnout, especially the Trustees coming out to do their part.

## **DISCUSSION & ACTION ITEMS**

- 1. Election Update: Turnout was good 34 Voters. All trustees on the ballot were elected to a term. Duke Gerber was retained as Mayor for a four year term. Art Fox and Dana Veljacic were re-elected for four year terms. Tom Henderson's term goes for two more years. Please welcome Bob Hill and Andy Fobair as new Trustees for four and two year terms. The nicotine tax passed: 29-5. The taxes on nicotine products does not change from current tax rate with a portion now being retained by Red Cliff for education of youth.
- 2. Stay at Home Order is still in effect, until the end of April. New in the Order is that we need to close the parks and dogs must be on leash. Staff will inform residents. In addition, there have been complaints about parties and fires up Shrine Pass. Staff will continue to alert authorities. If any residents see any fires or group gathering on Shrine Pass, please alert authorities to help keep Red Cliff safe.
- 3. The 2 Liquor Licenses in town are up for renewal. The board agreed to a temporary approval. The Liquor Board meeting will be held next month, due to COVID-19.

#### **UPDATES**

1. Mayor Update

Mayor Duke Gerber:

- Has noticed that our residents are doing very well at social distancing and being mindful of other's space.
- Had a conference call on March 25<sup>th</sup> with the Forest Service and Eagle River Water Council with an update on Wearyman. They are still trying to determine whether to repair or reclaim it. They will have crews continuing the work that they started last year, which will continue throughout this summer. He strongly expressed the importance to our Town of this being reopened.
- Will be moving forward with the horseshoe pits very soon.

## 2. Administrator Update

#### Administrator Barb Smith:

- There have been a few insurance claims due to loader accidents. The Town is not liable for these, due to Governmental Immunity. However, it would be good policy to cover the three deductibles. The Board agreed and directed staff to pay these deductibles.
- Due to the financial hardships brought on by COVID-19 to many of our residents, Barb proposed that the board forgive all water bills for residents and businesses for the month of March. This will cost the Town approximately \$22,000.

  Motion by Dana Veljacic to waive the water fees for the month of March seconded by Valarie

Blevins, unanimously approved.

- The Community Foundation has been asking other Towns for donations, as they have seen significant increases in need and usage due to COVID-19. They have not asked us for a donation, but we should consider offering, especially since they have doubled the amount of services they are offering to our Town. The Board agreed to donate \$1,000.
- Requesting a laptop for the Town Manager for offsite meetings and potential remote work requirements. The cost with all setup is \$2,400. The Board approved this purchase.

# 3. Other Staff/Trustee Updates

## Trustee Valarie Blevins

• The Townhome construction site is littered with trash. They have also pushed snow that has trash in it throughout Town and into water ways. Barb Smith has contacted them to remedy this situation.
