APPROVAL OF AGENDA

Motion by Art Fox to approve the agenda, seconded by Dana Veljacic, unanimously approved.

APPROVAL OF MINUTES

1. May 5, 2020

Motion by Tom Henderson to approve the minutes, seconded by Dana Veljacic, unanimously approved.

PUBLIC COMMENTS

Nathalie Roy, 410 Eagle Street #A:

- There are rocks at the end of Eagle Street blocking access. The Board clarified that this land is owned by the railroad and the homeowners lease their land from the railroad. Essentially, this is private property.
- Shrine Pass has concrete berms blocking the road. Staff clarified that the Forrest Service asked for
 it to remain until they open the gate. The purpose of these are to prevent people from getting
 stuck on the road before it is completely dried up.
- Inquired about the property where CBR has operated from, on Shrine Pass Road. Barb asked the board to direct her to reach out to Eagle County regarding this situation. The Board so directed.

Dana Veljacic, 336 Eagle Street:

• Inquired about the Green House on Water Street that has been under construction. There seems to be some safety concerns with kids playing on the property: the front door is open and there is a hole in the yard. Staff clarified that this is private property and the owner has a demo permit. There is not currently anything in the Code requiring fencing off construction sites.

DISCUSSION & ACTION ITEMS

1. Interview/Appointments for any applicants for the Planning & Zoning Committee Current members attended and desired to be reappointed including: Tom Henderson, Nathalie Roy, Bob Will, and Trish Marcine. There was an application submitted by Jake Blevins. Each person in attendance spoke about background and asked to be reappointed. There was also a discussion by the Board, attendees, and staff about the pros and cons of having the meeting days be the same as the Trustee meetings. The conclusion was that it makes most sense for the meetings to be on the same nights.

Motion by Art Fox to reappoint Tom Henderson, Nathalie Roy, Bob Will, and Trish Marcine to the Planning & Zoning Committee and to keep the meetings on the same nights as the Board of Trustees meetings, seconded by Duke Gerber, unanimously approved.

2. Historic Restoration Grants, Trail Grants

Old Town Hall building: Staff recapped previous Board's actions regarding the old Town Hall building. In 2011, the Town had a Historical Structure Assessment done on this building. The architects established a probable cost to have this building preserved and for it to be the Town's museum. At that time, the cost would have been about \$240,000 and the Board decided not to move forward with this project at that time. Staff is asking to move forward with this now that we are in a better position to do so. There is a History Colorado Grant that funds at 50% and we would need to get a matching grant(s) to cover the other 50%. Staff has done some of the recommended items in the report, including taking down the leanto on the side of the building. Xcel Energy required this due to the new pole's guide wire that was too close to the roof and shed section. Resident James Tange, 387 Eagle Street shared concerns about tearing down parts of this building. He was very adamant that he did not want this project to move forward without a better plan in place. The Board directed staff to move forward with the grant investigation for the Historic Renovation/Restoration of this building.

Trail Grant: Amelia has been working with Colorado Parks and Wildlife to help move the Iron Mountain trail system grant forward.

Streetscape Grant: We should find out if we are awarded the grant through DOLA next month.

3. COVID – 19 Updates

Eagle County is preparing to move into the "Blue" Phase of re-opening. Projected date for this is Monday, May 25th.
