## **DISCUSSION AND ACTION ITEMS**

1. Update on the EVTA – Executive Director, Tanya Allen

Tanya Allen gave a summary including: a recap the formation of the EVTA (about 6 months ago), the goals, and future plans. She discussed the funding streams and the process of establishing administrational structure and policies. She explained the relationship between EVTA and ECO Transit, the transitional time line, the interim strategic plan, and progress on future planning. Currently, some of the bigger challenges are around staffing and equipment. There will be a virtual meeting for stakeholder input regarding branding and marketing which all Trustees are welcome to join.

2. Animal Control IGA

The renewal contract for the Intergovernmental Agreement with Eagle County for animal control services was presented. Discussion included the cost of the services, which will be going up minimally as it does each year, as well as what services they offer.

#### STAFF/TRUSTEE UPDATES

Mayor, Duke Gerber:

- Will be submitting a letter of support for the Old Town Hall Most Endangered Places application.
- It was reported that Minturn and Battle Mountain developers have reached a settlement which
  will include significant new building of residential and commercial. This could impact Red Cliff in
  the future.
- It is noticed that the bears have been less active, but still stubborn and persistent.

## Administrator, Barb Smith:

- Regarding funding sources for the Streetscape Project, have completed the application for state funding that would cover the 20% match required for the Federal Grant. Also, now working on the Federal Grant application.
- Regarding the alternative curbing previously discussed, it is called a "mountable" monolithic curb, gutter, sidewalk. This option will likely be a great fit for Red Cliff as we do the Streetscape Project, as it is highly functional and will save time and money upfront and in the future.
- We had a request for a donation as well as an invitation to the Night of Excellence which is a
  fundraiser for local first responders. The Board agreed that the Town will not give a donation,
  however some Board members may choose to go and donate independently.
- We hired a Deputy Clerk: Chris Brown. He will be part time until winter and full time going into next year.

## Clerk, Melissa Matthews:

- Attended the CIRSA member appreciation luncheon with Dave and Billy. There were updates on wildfire preparedness, losses over the past year (hail damage up higher than ever), and alerted that rates for next year are going to be going up.
- At the Mayors/Managers meeting last week and the topics covered included: the status of the
  airport and a new customs division; upcoming housing planning around the county; and a brief
  explanation of Proposition HH as well as notification of other educational opportunities on this
  topic coming up.
- Upcoming events:
  - Thurs/Fri, 8/17-8/18: TransRockies: There will be three community members hired by the event coordinator to be 'Town Ambassadors'. They will be available during the event to ensure that there is no trespassing, speeding, or general disrespect to residents.
