

**TOWN OF RED CLIFF, COLORADO
ORDINANCE 1, SERIES 2026**

**AN ORDINANCE AMENDING CHAPTER 8 OF THE TOWN OF RED CLIFF
MUNICIPAL CODE CONCERNING PARKING ON MONUMENT STREET**

WHEREAS, the Town of Red Cliff ("Town") is a municipal corporation and body politic organized under the laws of the State of Colorado and possessing the maximum powers, authority and privileges to which it is entitled under Colorado law; and

WHEREAS, the Town, by virtue of its status, may adopt ordinances relative to local municipal matters as are necessary to effectuate the purposes and intent of the powers granted to municipalities; and

WHEREAS, the Town, acting by and through the Board of Trustees (the "Board"), has the power to amend the Municipal Code of the Town (the "Code") and all such amendments shall become a part of the Code; and

WHEREAS, C.R.S. § 42-4-111 provides that local authorities may regulate or prohibit parking of vehicles on streets and highways within their jurisdiction; and

WHEREAS, Section 8-2-50 of the Code provides specified parking restrictions within Town streets and rights-of-way; and

WHEREAS, the Board finds that parking at the west end of Monument Street creates safety risks which could prevent emergency vehicles from effectively accessing the area; and

WHEREAS, the Board believes it is in the best interests of the Town to prohibit parking for the westernmost One Hundred and Twenty-Five (125) feet of the street.

**NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE TOWN OF RED CLIFF,
COLORADO, ORDAINS:**

Section 1: The Board hereby amends Code Section 8-2-50, with changes in **bold underline**, to read as follows:

Sec. 8-2-50. Specified parking restrictions.

The following are parking restrictions within specified Town streets and rights-of-way:

- (1) Water Street: Parking is only permitted within the 500 block of Water Street on private property.
- (2) Turkey Creek Road and High Street: No on-street parking is permitted.

**(3) Monument Street westernmost One Hundred and Twenty- Five (125) feet of the street:
No on-street parking is permitted.**

INTRODUCED, TITLE READ IN FULL, APPROVED ON THE FIRST READING AND ORDERED POSTED IN FULL THIS 3rd DAY OF FEBRUARY 2026. A public hearing on the SECOND READING of this Ordinance will be held at the regular meeting of the Board of Trustees of the Town of Red Cliff on the 3rd day of February 2026 at in the Town Hall of the Town of Red Cliff.


