A RESOLUTION AUTHORIZING EAGLE COUNTY, COLORADO, TO COLLECT SPECIFIED DELINQUENT FEES WITH THE GENERAL PROPERTY TAX FOR THE TOWN OF RED CLIFF, COLORADO.

WHEREAS, the Town of Red Cliff is a statutory municipality under the laws of the state of Colorado, and:

WHEREAS, the Town of Red Cliff provides services for the residents of the Town of Red Cliff in return for fees billed and collected monthly, and;

WHEREAS, the Town of Red Cliff recognizes that the County of Eagle, Colorado, established a process assuring statutory compliance of the governing body, due process for the property owners, and timely collections, and;

WHEREAS, the Town of Red Cliff understands that it shall pay the Treasurer of Eagle County, Colorado, 10% as compensation for the extra labor as allowed in CRS 32-1-1101(1)(e), and;

WHEREAS, the Town of Red Cliff recognizes that certification of delinquent fees for collection with general property taxes requires:

- 1. Name of the district
- 2. Name of assessed party and current mailing address
- 3. Full legal description and site address
- 4. Parcel number
- 5. Schedule number

A copy of the 2019 Certifications of Delinquency is attached as Exhibit A and incorporated herein.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN OF RED CLIFF BOARD OF TRUSTEES, COLORADO THAT:

- 1. The attached list shall serve as a list of all accounts currently delinquent that the Town of Red Cliff Board of Trustees asks the County of Eagle, Colorado, to collect with general property taxes.
- 2. This Resolution shall take effect immediately upon its passage.
