**A RESOLUTION OF THE BOARD OF TRUSTEES OF THE TOWN OF RED CLIFF,
COLORADO, APPROVING THE CREATION OF THE DEFENSIVE DRIVING
SCHOLARSHIP PROGRAM**

WHEREAS, the Town of Red Cliff, Colorado (the "Town"), is a statutory town and political subdivision of the State of Colorado, duly organized and operating under the constitution and laws of the State of Colorado; and

WHEREAS, the Town seeks to provide financial assistance for defensive driving courses to youth in the municipality through a scholarship program;

WHEREAS, the funding for the scholarship shall originate from the Red Cliff Community Fund;

WHEREAS, the recipient must meet and complete the qualifications described in the application, Exhibit A;

WHEREAS, the number of recipients shall be determined each year by the Members of the Board depending on the fund's capability;

WHEREAS, the program's obligation to scholars shall be paid directly to the Colorado Safe Driver organization upon registration of class(es);

WHEREAS, a maximum sum of Two Hundred Dollars (\$200.00) per recipient shall be appropriated;

WHEREAS, the Town's staff shall review applications and assist applicants with registration;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF RED CLIFF, COLORADO, we approve creation of the Defensive Driving Scholarship Program.

Defensive Driving Courses Scholarship Program

The Red Cliff Community Fund is dedicated to helping youth of the community of Red Cliff to attend Defensive Driving classes approved through the Colorado Safe Driver organization (www.coloradosafedriver.org).

This scholarship award ceiling is \$200 per youth resident. The funds will be paid directly to the Colorado Safe Driver organization at the time of course registration. Recipients must work with Town staff to register.

Criteria and eligibility

1. Applicant must be a resident of the Town of Red Cliff.
2. Applicant must be between the ages of 15-18 years.

General Instructions/Application Process:

1. Visit www.coloradosafedriver.org and decide on the course or courses that you are interested in.
2. Contact the Town office with selected course or courses. Staff will register you and send you the link for the course: clerk@townofredcliff or 970-827-5303.

There is no deadline for the application, as this program will continue as long as the courses are available through the Colorado Safe Driver organization.
