## TOWN OF RED CLIFF, COLORADO RESOLUTION NO. 2, SERIES 2018

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE TOWN OF RED CLIFF, COLORADO, SUBMITTING TO THE QUALIFIED ELECTORS OF THE TOWN OF RED CLIFF AT THE APRIL 3, 2018 REGULAR MUNICIPAL ELECTION A BALLOT QUESTION ASKING WHETHER TERM LIMITS IMPOSED ON MEMBERS OF THE TOWN BOARD OF TRUSTEES SHOULD BE ELIMINATED

WHEREAS, the Town of Red Cliff, Colorado ("Town") is a statutory municipal corporation duly organized and existing under the laws of the State of Colorado and possessing the maximum powers, authority, and privileges to which it is entitled under Colorado law; and

WHEREAS, pursuant to Article XVIII, Section 11 of the Colorado Constitution, each trustee on the Town Board of Trustees, including the Mayor, ("Board") is limited to serving two consecutive terms on the Board; and

WHEREAS, there has been limited interest from residents of the Town to serve as a trustee on the Board, and, at times, the Board has not been able to fill vacant seats; and

WHEREAS, the voters in the Town may lengthen, shorten, or eliminate term limits through an election; and

WHEREAS, removing term limits will allow interested and committed individuals to remain on the Board subject to their reelection by the citizens, which will help maintain a full and functioning Board to govern the Town; and

WHEREAS, the Town's next regular municipal election will be held on April 3, 2018, and conducted pursuant to the Colorado Municipal Election Act of 1965; and

WHEREAS, the Board desires to submit to the electors of the Town voting at such election the question of eliminating term limits for the Mayor and members of the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF RED CLIFF, COLORADO, AS FOLLOWS:

- Section 1. The foregoing recitals are incorporated by reference herein as findings and determinations of the Board.
- Section 2. The following Ballot Question shall be submitted to the qualified electors of the Town voting in the regular municipal election to be held on April 3, 2018:
